## LOGO REQUIREMENTS

- Per Montana Code Annotated 61-3-405, the department may refuse to issue any combination of letters or numbers, or both, that may carry connotations offensive to good taste and decency or which are misleading or a duplication of license plates provided for elsewhere in Title 61 of statute.
- A personalized plate logo must have at least 2 alpha-numeric characters and cannot be all spaces or all numbers.
- The alpha character "O" cannot be used. The numeric "0" will be substituted for the alpha "O."
- Characters may be repeated.
- Using an ampersand character (&) for "and" is allowed.
- When determining the total number of characters, each space will be counted as a full character.
- Spaces cannot be used at the beginning or end of the logo choice.
